ARGO SENIOR ACTIVITY CENTER RULES AND REGULATIONS

The purpose of the Argo Senior Activity Center is to provide citizens of Argo who are over the age of fifty (50) with an opportunity to fellowship, play cards, games or perhaps have lunch together. The

Center offers exercise equipment (to keep your body moving) and a computer (to keep your mind sharp.)

You may join the lunch group called the "59er's" who meet on the first and third Mondays of each month. They bring a "brown-bag" lunch on the first Monday and a covered dish to share on the third Monday. They meet at 10:30 and snack and fellowship until lunch which usually begins around 11:30.

The Senior Activity Center does not offer personalized services, medical care, or intensive supervision. Members are required to provide for their own personal and medical needs. By signing the membership application you agree to hold harmless the Town of Argo for any and all injuries incurred while on Town property through no fault of the Town of Argo.

- 1. You must be age 50 or older or an employee of the Town of Argo to use the exercise equipment.
- 2. You may bring 2 visitors (age 18 or older.)
- 3. Hours of operation are 8 a.m. to 3:30 p.m. Monday through Friday (except holidays.)
- 4. You must wear closed-toe shoes (no flip-flops) to use the exercise equipment. Appropriate dress is always required.
- 5. No children are allowed in the Senior Activity Center.
- 6. The equipment and property in the Senior Activity Center are not to be moved out of the Senior Activity Center.
- 7. No alcoholic beverages, illegal drugs, smoking, gambling or firearms are permitted in and around the Senior Activity Center.
- 8. The computer is not for public use. It is strictly for the use of the Senior Members.
- 9. The telephone is for local calls only, if needed.
- 10. Members are required to keep their emergency contact information updated on an as needed basis to ensure that the Senior Activity Center has the ability to contact the appropriate person in case of emergency.

The Senior Activity Center reserves the right to limit or refuse admission to any Member who is in violation of these rules or policies applicable to the Senior Activity Center.

In addition, an person who violates the rules and regulations of the Senior Activity Center or any other laws or policies applicable to the Senior Activity Center may be required to vacate the Senior Activity Center and may be prohibited from further use of the Senior Activity Center.

The Argo Senior Activity Center is to be used primarily for its Members. Upon the determination by

the Council that there is no conflict between such regular use and a special unrelated use, the kitchen may be rented or utilized by Members or other members of the community for special events.

Special use of the facility may be allowed upon application, execution of an agreement to abide by the rules and regulations, and the provision of security for damage to the facility or contents.

If use of the kitchen is approved, no equipment or tools may be removed from the kitchen. In addition, the applicant is responsible for providing his or her own equipment and utensils. Any use of the Center's equipment must have specific approval.
