Attorney Brunson read Resolution 2020-09-01, Canvassing of Election Returns, aloud, asking the council for a motion.

Councilperson Massey made the motion to approve the above the resolution canvassing the results of the election. Mayor Pro-Tem Alldredge seconded the motion. Attorney Brunson called for roll call of votes: Cowan-yea, Massey-yea, Alldredge-yea, Brown-yea, and Mayor Bradley-abstain. Motion carried.

Mayor Bradley updated the council of her progress on the hiring efforts for a new maintenance manager. Councilperson Massey, herself, and Mr. Stinson conducted several interviews last week. There were several candidates and after interviewing them all, it was ultimately decided it would be best to hire Darrell Glass back with a raise, it would save the city money in the long run as they would not have to train anyone to learn the job he does so well.

Mayor Bradley asked the council to approve the hiring of Darrell Glass at \$19.00 per hour as he is the best candidate. Councilperson Brown made the motion to approve the hiring of Darrell Glass. Mayor Pro-Tem Alldredge seconded the motion. Mayor Bradley called for roll call of votes: Cowan-yea, Massey-yea, Alldredge-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Massey presented the council with an updated road paving sheet, he received from Mr. Charles Pullin. It shows Freeze Mtn/Masters Rd, Cedar Creek, Rocky Ridge Rd, and InTha Woods Rd, to be paved for \$236,088.72.

Councilperson Massey made a motion to approve the paving for the above stated 5 roads using half of the funds from the road accounts and half from the 610 account. Councilperson Cowan seconded the motion. Mayor Bradley called for roll call of votes: Cowan-yea, Massey-yea, Alldredge-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Massey amended the above the motion with a time limit of 90 days, also if said work couldn't be completed within this time frame, work will be completed with favorable weather, and the price point would remain the same, all the council were in agreement.

Dusty Stinson, spoke at tonight's meeting, he purchased a StreetScout Radar Speed Trailer to donate to the city in hopes to help with some of the areas that have speeding problems, where our officers can't be all the time. It should be in by the end of the September.


Councilperson Massey motioned to adjourn. Councilperson Brown seconded the motion. All were in favor. Motion carried.
