Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the above listed persons were present.

Invocation was given by Beth King, and the pledge of allegiance was recited by those in attendance.

Mayor Bradley addressed the council with the first order of business, minutes from the council meeting dated 12-01-2020. Councilperson Brown motioned to approve the minutes from Work Session. Mayor Pro-Tem Stinson seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-abstain, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Griffin motioned to approve the minutes from Regular Meeting 12-01-20 with no changes. Mayor Pro-Tem Stinson seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-abstain, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Brown motioned to approve the CARES Act resolution 2020-12-00. Councilperson Hicks seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Brown motioned to approve the use of city facilities by members of the police department for training classes. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinson motioned to approve repairs of the septic system to the Argo city

property at 8885 Hwy 11. Councilperson Brown seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Hicks motioned to cancel the Argo Christmas parade for 2020. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinson motioned to enter into an executive session. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinson motioned to allow the Mayor to enter into payment arrangements with a former employee. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-Abstained. Motion carried.

City Attorney Report: No new business.

Mayor Report: Mayor reported that the contract for the FLOCK cameras had been executed, and installation is set to begin.

Two interviews for the opening in the police department had been completed with an additional interview to be completed next week.

During a meeting with the Waste Management representative, he had requested 3 months to correct issues with the trash collection in Argo prior to the City seeking other bids.

Council Comments: Councilperson Brown requested an update of streetlights from Alabama Power. Mayor Pro-Tem Stinson related that a cost of approximately 10.61 per light would be required for additional lights on Blackjack and Roulain Rd.

Public Comments: No public comments.

Councilperson McCarley motioned to adjourn the meeting. Meeting adjourned.
