Councilperson Brown motioned to approve the minutes from Work Session and Regular meeting. Mayor Pro-Tem Stinson seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Brown motioned to approve the minutes from the work sessions dated 01-13-21 and 01-18-2021. Councilperson Brown motioned to approve the minutes from Work Sessions. City Attorney Report: No new business.

Mayor Report: Mayor reported that the city had been turned down for a grant to improve the roads.

Additionally, the Mayor noted that the audit is complete, awaiting a letter from the former city attorney.

Council Comments: Mayor Pro-Tem Stinson noted that the property at 8885 Hwy 11 had been cleaned out, leaving 3 kitchen items to be placed for sale on the internet, but the property is still in need of additional repairs. He would contact a handyman service about completing the needed repairs.


The work session consisted of discussion on the January 25, 2021 regular council meeting agenda.
