Councilperson Griffin motioned to table item #8- Sell of the brush truck until the next scheduled meeting. Councilperson Hicks seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinson motioned to suspend the rules to add the \$5,000 AMIC deductible claim to the agenda. Councilperson McCarley seconded the motion. Mayor Bradley called for
