Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the above listed persons were present.

Invocation was given by Mr. Mike King, and the pledge of allegiance was recited by those in attendance.

Mayor Pro-Tem Stinson motioned to approve the work session and regular meeting minutes as submitted from 03/22/2022. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

FIRE REPORT – Chief Scott Payne gave the monthly fire report. The fire department had a total of 43 calls for the month of March and issued 4 burn permits, responded to 3 grass fires, and 27 medical calls, and responded to 2 structure fires. Chief Payne also update the council they are still working on ESO, the bay doors are going up this week, and the FD will be hiring Christian Gonzalez, to replace Evan Massey, and Gregory Barber to fill the spot approved in the budget.

POLICE REPORT – Chief Wells gave the monthly police report, they had 192 dispatched for the month of March, Chief Wells said this was the lowest he has seen it in a long time, 5 felony arrests, 3 of which were made during court, 9 misdemeanor arrests, and 46 interstate calls. He also informed the council that Officer Dison went to FTO training this past week, and Officers Davis and Mitchell will be attending the ARIDE training next week, and the PD was lucky enough to get the FATS simulator for a week.

FOOD BANK REPORT-No new business.

BUSINESS CLUB REPORT- No new business.

Councilperson Brown motioned to approve Ordinance 2022-04-11, An Ordinance Repealing Ordinances 2001-185 And 2020-11-11 And Replacing Those Ordinances with A Revised and Updated “Safe Streets” Ordinance That Provides for The Impound of Certain Vehicles in Public Right-Of-Ways and Providing a Process to Release Impounded Vehicles. Mayor Pro-Tem Stinson seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-nay. Motion carried.

Councilperson Brown motioned to approve Danny McCarley to be the AMIC voting delegate during the convention. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

MAYOR REPORT –Mayor Bradley reminded everyone about the “Meet & Greet” for all the local candidates running, it will be tomorrow, Tuesday April 12th, 2022, at 6pm at City Hall, Scott Buttram from the Trussville Tribune will be the moderator for this event. April 26th will be the mid budget review at 5pm, and Tuesday May 3rd the city will host the mayors’ breakfast here at city hall at 7:30AM. She also reminded everyone city hall will be closed on Monday May 30th in observance of Memorial Day.

CITY ATTORNEY –No new business.

Councilperson Brown wanted to mention that the book nook dedication was this past Saturday April 9th, 2022, at 11:30 at the park, and it went great, there were several children who showed her and received a free book. She thanked everyone who came out to participate.
