ROLL CALL

Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the above listed persons were present.

Invocation was given by Fire Chief Scott Payne, and the pledge of allegiance was recited by those in attendance.

Councilperson Ann Brown motioned to approve the work session minutes and regular meeting minutes with corrections discussed from 05/25/2022 and work session minutes and regular meeting minutes as presented from 6/13/2022. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Griffin motioned to approve the purchase of a pressure washer in the amount of \$654.49, with funds coming from Capital Improvement. Councilperson Hicks seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Brown motioned to suspend the rules to add the quote from A Plus Concrete and Seal Coating, as well as the bid for the striping of Roulain Road to the agenda. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried

Councilperson Brown motioned to approve the bid for A Plus Concrete and Seal Coating, as quoted, dig out area shown by mayor approx 70 feet by 2 feet wide pouring flume with 6 inch curb on top to run into other flume Dig out area shown by mayor approx 70 feet by 2 feet wide pouring flume with 6 inch curb on top Then install 6 concrete stop blocks in front of flume at parking places, in the amount of \$4,962 dated 6/6/2022. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Councilperson Griffin motioned to approve the estimate presented for the striping of Roulain Road, for plastic paint in the amount of \$14,720, and reflectors in the amount of \$2,050, totaling \$16,770, funds to be used from the ARPA fund. Councilperson Brown seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Mr. William McPherson of 988 Blackjack Road was present at tonight's meeting to express sincere concern about speeding and reckless driving in the area. He and his wife Wanda have been lifelong residents of the community and are truly concerned about the increase in speeders and reckless drivers. Mayor Bradley and the council expressed their empathy with Mr. McPherson but told him ultimately since Blackjack is a county road, the city is restricted to what they are able to do, in years past they have tried to help with similar situations but were unsuccessful, they suggested he go before the county commissioner, and see if his voice can be heard. Mayor Bradley and Police Chief Wells did say they could have more patrol in the area, but this will only help with so much. He thanked them for their time and took their advice under advisement.

CITY ATTORNEY – No new business.

MAYOR REPORT – Mayor Bradley informed the council the city clerk and herself as well as 2 police personnel would be attending an AMIC conference in Gunterville, August 9th.

Councilperson McCarley did mention he was able to add the Disc Golf course to google maps last week, and it has already received over 1k views.

A motion was made to adjourn. All in favor. Meeting adjourned.
