Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the above listed persons were present.

Invocation was given by Fire Chief Scott Payne, and the pledge of allegiance was recited by those in attendance.

Councilperson Brown motioned to approve the work session and regular meeting minutes with change from 6/27/2022. Councilperson Hicks seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

FIRE REPORT – Chief Scott Payne gave the monthly fire report, they had 5 burn permits issued for the month of June, the reason for so few issued is there was a no burn for most of the month, 33 medical calls, 2 brush fires, 1 car fire for 44 total calls for the month. Chief Payne did inform the council that they are still actively working on the letter drive, and he would be hiring 2 more guys, Keith McLaughlin & Kade Spraggins, to replace 2 that left.

POLICE REPORT – Chief Wells gave the monthly police report, they had 300 dispatched for the month of June 7 felony reports, 8 K-9 calls, 5 of which resulted in arrests, and 26 misdemeanor arrests.

Councilperson McCarley motioned to approve Resolution 2022-07-11, A Resolution Declaring Certain Personal Property of The City of Argo, Alabama, To Be Surplus and Authorizing Its Disposal. Councilperson Hicks seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Hicks-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

MAYOR REPORT –Mayor Bradley wanted to thank Mr. Bob Carter, Karen & Richard Melvin, & Mike & Beth King for hosting the employee appreciation lunch for the city employees and their families. She reminded everyone that Blackjack Road will be closed starting Wednesday from 8:30-2:30. City Hall will close at noon on Wednesday July 27th for clerk/magistrate training. She also wanted to let everyone know that the city has been added to the schedule for the striping of Roulian Road and the work around the back of city hall, there is no time frame yet.

CITY ATTORNEY –No new business.


A motion was made to adjourn. All in favor. Meeting adjourned.
