## ROLL CALL

Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the above listed persons were present.

Invocation was given by Mayor Pro-Tem Stinson, and the pledge of allegiance was recited by those in attendance.

Mayor Por-Tem Stinson motioned to approve the work session minutes and regular meeting minutes from 8/8/2022 as presented. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, and Mayor Bradley-yea. Motion carried.

Mr. Chris McCombs was in attendance for tonight's meeting, expressing his concern about roosters being back at 1284 Argo-Margaret Rd. This was an issue 2 years ago, and was supposed to be taken care of, but the issue has returned. Mr. McCombs wanted to know what the city could do to help with the situation. City attorney Brymer explained that there were two different scenarios, Mr. McCombs could come and see the magistrate, to have a warrant sworn out for the homeowners/residents, or the city could put the homeowner on notice again to appear in front of the council. Mr. McCombs stated he wasn't interested in nor had the time to have anyone arrested or come to court. Mayor Bradley asked Chief Wells if he would mind going out to the residence home and investigating the situation and reporting back to her. He was happy to do so.

Mayor Pro-Tem Stinson motioned to approve Resolution 2022-08-22, A Resolution for Officer Selected to Fill a Vacant Seat for Place Number Two (2) On the City Council of The City of Argo, Alabama, Naming Thomas Suggs, as the chosen candidate. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinson motioned to approve Resolution 2022-08-22A, A Resolution Authorizing the City of Argo, Alabama to Join the State of Alabama and Other Local Governments as Participants in

Current Opioid Settlements. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinon motioned to approve Resolution 2022-08-22B, A Resolution Adopting the Transportation Plan for the 2022-2023 Fiscal Year for The City of Argo, Alabama. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, and Mayor Bradley-yea. Motion carried.

Mayor Pro-Tem Stinson motioned to table the employee vacation policy amendment until the attorney can get something in writing. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Stinson-yea, McCarley-yea, and Mayor Bradley-yea. Motion carried.

MAYOR REPORT – Mayor Bradley remined everyone that we will have Goodwyn, Mills, and Cawood present at the next council meeting to discuss the progression thus far on the zoning with the steering committee.
