Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the above listed persons were present.

Invocation was given by Mr.Bob Carter, and the pledge of allegiance was recited by those in attendance.

FIRE REPORT — Lieutenant Brent Rejonis gave the monthly fire report. The fire department had a total of 65 calls for the month of October, responded to 15 brush/kitchen fires, and 34 medical calls. Lt. Rejonis updated the council on the mini pumper truck, they are still waiting on hoses for it, then it will be ready to be put into service.

POLICE REPORT – Chief Glenn Wells gave the monthly police report, they had 276 dispatched for the month of October, 6 felony arrests, 20 misdemeanor arrests, 5 K-9 calls, resulting in 3 arrests, 21 fire department assists, 8 animal complaints. Councilperson Brown asked about the increase in the number, Chief Wells informed her it was for all animals, pigs, horses, goats, etc., Chief Wells also let the council know that one of the brand-new PD cruisers engines has blown, and is in the shop, it should be under warranty.

Councilperson Suggs motioned to approve the Regular meeting minutes and Work Session minutes from 10/24/2022. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Suggs-yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.

Mrs. Karen Melvin presented her updated platt map for Lee Garden, she showed the council the corrections made to the map, for consideration. Councilperson Brown motioned to approve the updated platt map for Lee Garden as submitted. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Suggs-yea, McCarley-yea, Brown-yea,

Councilperson Griffin motioned to approve the changing of the second regularly scheduled council meeting in December from December 26th to December 19th at 5pm, due to city hall being closed for the holidays. MAYOR REPORT —Mayor Bradley reminded everyone that City Hall will be closed Thursday November 24th, and Friday November 25th for Thanksgiving. We are now accepting applications for Christmas for kids, now through Friday December 9th. The giveaway will be the Wednesday after the Christmas parade, December 14th, from 4-6pm. The Christmas Parade is on Saturday December 10^{th at} 10am. She also let the council know that the part time city clerk has turned in her notice and will be leaving the city. Mayor Bradley also thanked everyone who had a hand in helping with the monster mash, it was a huge success, Matt Hollis, with Printcorp, Branden Bowen with Grantcrossing, Corky Massey and his wife, city employees, all the council that was able to attend and run the games, Councilperson Brown for organizing it, Massey, Stotser, & Nichols, PC, Alabama Tourism grant, Gary Gerson, Sharon McCoy, and of course the public for making it such a hit. Mayor Bradley also wanted to let everyone know that we have received the architectural drawings for the entrance to city hall and should have news on it soon.

CITY ATTORNEY –No new business.

Councilperson Brown briefly mentioned float ideas for the Christmas parade, and the what would be needed for them.
