

RESOLUTION NO. 2023-05-08

A RESOLUTION APPOINTING THE INITIAL MEMBERS TO THE BOARD OF ZONING ADJUSTMENT OF THE CITY OF ARGO, ALABAMA.

WHEREAS, on February 27, 2023, the City Council of the City of Argo, Alabama, adopted Ordinance No.2023-02-13 which created and established the Planning and Zoning Commission of the City of Argo, Alabama (“Commission”); and

WHEREAS, the City Council of the City of Argo, Alabama, adopted Ordinance No. 2023-04-24 which created its Board of Zoning Adjustment to hear appeals from certain decisions of the Commission where authorized by law; and

WHEREAS, with the impending presentation of and potential adoption of the City of Argo Zoning Ordinance, pursuant § 11-52-80 of the Code of Alabama (1975) the City Council finds it in the best interest of the health, safety, and welfare of its citizens to proceed to name and appoint members of its Board of Zoning Adjustment (“BZA”), so that the Commission and BZA have members in place ready to begin business upon the public hearing and potential adoption of the City of Argo Zoning Ordinance; and

WHEREAS, the City Council names and appoints the members identified below to the corresponding terms mentioned below.

WHEREAS, these initial appointments and their corresponding terms are made pursuant to § 11-52-80 of the Code of Alabama (1975).

NOW THEREFORE, BE IT RESOLVED by the City of Council of the City of Argo, Alabama, while in regular session, that the following:

Section 1. The preamble stated above is hereby adopted and incorporated as if fully set out herein.

Section 2. Pursuant to § 11-52-80 of the Code of Alabama (1975) and Ordinance No.2023-04-24 the following appointments are made to the Board of Zoning Adjustment:

- (1) (a) Member 1 Myron "Rusty" Allen, a resident of the City, whose term shall commence on the date of this Resolution and expire one (1) year thereafter;
- (b) Member 2 Heather Gober, a resident of the City, whose term shall commence the date of this Resolution and expire one (1) year thereafter;
- (c) Member 3 James Hyatt, a resident of the City, whose term shall commence on the date of this Resolution and expire two (2) years thereafter;

(d) Member 4 Michelle Coalson, a resident of the City, whose term shall commence on the date of this Resolution and expire two (2) years thereafter;

(e) Member 5 James "Mike" King, a resident of the City, whose term shall commence on the date of this Resolution and expire three (3) years thereafter.

Section 3. (a) In addition to the BZA members appointed above, the following individuals, who are residents of the City, are appointed as supernumerary members of the BZA:

(1) Howard Hartley; and

(2) TBD.

(b) These supernumerary members may only participate when there is an absence of a regular member. The chair of the BZA shall notify the supernumerary member(s) of his or her need for participation.

(c) The term of these supernumerary members shall be three (3) years beginning on the effective date of this Resolution.

Section 4. All members of the Commission shall serve without compensation.

Section 5. This Resolution shall become immediately effective upon its adoption.

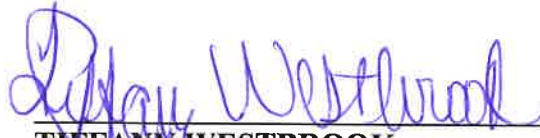
