

RESOLUTION NO. 2023-04-10

A RESOLUTION APPOINTING THE INITIAL MEMBERS TO THE PLANNING AND ZONING COMMISSION OF THE CITY OF ARGO, ALABAMA.

WHEREAS, on February 27, 2023, the City Council of the City of Argo, Alabama, adopted Ordinance No. 2023-02-13, which created and established the Planning and Zoning Commission of the City of Argo, Alabama (“Commission”); and

WHEREAS, pursuant to Ordinance No. and § 11-52-3 of the Code of Alabama (1975) members are now due to be appointed with the terms of the members affixed hereto; and

WHEREAS, in advance of making these appointments, the City Council

WHEREAS, these initial appointments and their corresponding terms are made pursuant to § 11-52-3 of the Code of Alabama (1975) and Ordinance No. 2023-02-13.

NOW THEREFORE, BE IT RESOLVED by the City of Council of the City of Argo, Alabama, while in regular session, that the following:

Section 1. The preamble stated above is hereby adopted and incorporated as if fully set out herein.

Section 2. Pursuant to § 11-52-3 of the Code of Alabama (1975) and Ordinance No.2023-02-13 the following appointments are made to the Commission:

(1) The Mayor (or her designee), whose term shall continue until a new Mayor is duly elected and takes office;

(2) Tiffany Westbrook as the City’s administrative official of the City and appointed by the Mayor the term of which shall continue until a new Mayor is duly elected and takes office;

(3) (a) Member 1 Laine Kendrick a resident of the City, whose term shall commence on the date of this Resolution and expire December 31, 2023;

(b) Member 2 Matthew Vincent a resident of the City, whose term shall commence the date of this Resolution and expire December 31, 2024;

(c) Member 3 Chase Gohser, a resident of the City, whose term shall commence on the date of this Resolution and expire December 31, 2025;

(d) Member 4 Michael Stanley, a resident of the City, whose term shall commence on the date of this Resolution and expire December 31, 2026;

(e) Member 5 Robert "Bob" Carter, a resident of the City, whose term shall commence on the date of this Resolution and expire December 31, 2027; and

(f) Member 6 Randy Hettich, a resident of the City, whose term shall commence on the date of this Resolution and expire December 31, 2028.

(4) Councilor Thomas Suggs who serves as an ex officio member and, by passage of this Resolution, has been duly selected by the city council to fill the position throughout this councilor's remaining term of office.

Section 3. All members of the Commission shall serve without compensation.

Section 5. This Resolution shall become immediately effective upon its adoption,
