Mayor Bradley called the meeting to order and asked the clerk for a roll call. The clerk called the roll, and the roll call is listed above.

Councilperson Hopkins motioned to approve the Regular meeting minutes and Work Session minutes from 7/24/2023 with changes discussed during the Work Session. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Suggs-abstain, Hopkins-yea, McCarley-yea, Brown-yes, and Mayor Bradley-yea. Motion carried.

Councilperson Hopkins read Ordinance No. 2023-08-28: To Require Building and Construction Permits and to Establish Fees Therefore. McCarley made a motion to adopt Ordinance No. 2023-08-28. Councilperson Hopkins made a motion to approve of hiring new city maintenance worker, Nicholas Morrison. Mayor Pro-Tem Brown seconded the motion. Mayor Bradley called for roll call of votes: Griffin-yea, Suggs-yea, Hopkins – yea, McCarley-yea, Brown-yea, and Mayor Bradley-yea. Motion carried.
