## **Regular Meeting**

### ROLL CALL

Mayor Bradley called the meeting to order and asked for a roll call. Roll was called and the roll call is listed above.

The invocation was given by Councilperson Hopkins and the Pledge of Allegiance was recited by those in attendance.

Mayor Pro-Tem Brown motioned to approve the Regular meeting minutes and Work Session minutes from 02/26/2024. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Suggs-abstain, Hopkins-yes, McCarley-yes, Brown-yes. Bradley-abstain. Motion carried.

**POLICE REPORT** – Corporal Cason Davis gave the Police Report for February. APD had a total of 578 calls for February which included 235 traffic stops.

Corporal Davis also recognized members of The Exceptional Foundation in attendance, including Argo resident, Justin Whitfield, for their achievements in recent Special Olympics events, including winning several medals in bowling at the Unified Bowling National Championship. Representatives from The Exceptional Foundation were given a certificate of appreciation from the City for their work with special needs adults.

**FIRE REPORT** – Jorrell Barrett gave the monthly fire report. Argo FD had a total of 55 calls in February.

Councilperson McCarley made a motion to approve GFL Environmental garbage service 3% increase. Councilperson Hopkins seconded the motion. Mayor Bradley called for roll call of votes: Suggs-yes, Hopkins-yes, McCarley-yes, Brown-yes. Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to approve the quote for mulch for the park, from Rubber Mulch Warehouse in the amount of \$4235.00, with the money to come out of the Capital

Improvement Fund. Councilperson Hopkins seconded the motion. Mayor Bradley called for roll call of votes: Suggs-yes, Hopkins-yes, McCarley-yes, Brown-yes. Bradley-yes. Motion carried.

**MAYOR REPORT** – Mayor Bradley updated the council on repairs to the water heater at City Hall. The current water heater can't be repaired. Quotes will be obtained for a new one and will be approved by the council at that time.

**CITY COUNCIL** – Mayor Pro-tem Brown reminded everyone about the Mayor's Breakfast coming up in Steele.

Mayor Pro-tem Brown and Mayor Bradley drove the roads in Argo and made notes on what needs repairs. A discussion will be held at the next council meeting.

**CITY ATTORNEY** – no new business.
