- A copy of food stamps award letter, Medicaid letter, or any other form of government assistance award letters

Children are eligible up to 15 years old. If you do have 16 – 18-year-old children in the home with younger children who are qualified for ACFK, please add them to your application info sheet so that we can try to arrange a sponsor. We cannot guarantee sponsors, but we will make every effort to get them sponsored.

Waiver & Release of Liability, Assumption of Risk, and Indemnity Agreement

1. In return for being allowed to participate in Argo Christmas for Kids program, including any activities incidental to such participation, I hereby voluntarily and knowingly agree to release, indemnify, defend, hold harmless, and covenant not to sue Argo Christmas for Kids, and its officers, directors, staff, employees, sponsors, agents, volunteers, and affiliates for any and all liability, claims, costs, and causes of action, including, but not limited to, any claim arising out of the ordinary negligence of any of the foregoing, that may be made by me, my family, estate, heirs, or assigns for property damage, personal injury, or wrongful death that may be sustained by me arising as a result of my participation in program services offered by Argo Christmas for Kids, or while on the premises owned or leased by the city of Argo.

2. I understand and agree that Argo Christmas for Kids is not responsible for any injury or property damage arising out of my participation in the program services. I understand that participation in the program services involves certain risks, including, but not limited to, serious injury and death.
