Mayor Pro-Tem Brown made a motion to approve the minutes of the Work Session and Council Meeting held on July 14, 2025. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to table the Sain Associates item until the next scheduled meeting on August 11, 2025. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to reschedule the regularly scheduled meeting of Monday, August 25, 2025, to Tuesday, August 19, 2025. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Councilperson Griffin made a motion to approve participation in the 2026 Severe Weather Preparedness Tax Holiday, scheduled for February 20–22, 2026. Councilperson Suggs seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to approve the Charitable Gift Agreement with Gordon

H. Massey, Jr., with the following amendments to be added by the City Attorney: the agreement shall be for a term of three years, and if construction has not begun within that time, the property will be returned to the donor upon request; if the cost of construction is determined to be prohibitive, the property will be returned to the donor and if the property is not used as a storm shelter, it will be returned to the donor. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to approve the purchase of a 2025 Ford Police Interceptor AWD Utility – T191L in the amount of \$54,041.00, along with \$12,000.00 for vehicle equipment, with total funds not to exceed \$66,041.00, to be paid from the Police Department Fund Account. Councilperson Hopkins seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to declare a K-9 metal kennel and electronic control unit as surplus. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Councilperson Hopkins made a motion to approve the Fall Festival to be held on Saturday, October 25, 2025, from 2:00 p.m. to 4:00 p.m., and to approve funding in the amount of \$6,500.00, along with a \$1,000.00 donation from Massey, Stotser & Nichols, for a total of \$7,500.00. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to approve the purchase of two (2) benches for Argo Park in the amount of \$2,235.78, to be paid from the Capital Improvement Funds. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggsyes, Hopkins-yes, McCarley -yes, Brown- yes, Bradley-yes. Motion carried.
