Mayor Pro-Tem Brown made a motion to approve the minutes of the Work Session and Council Meeting held on September 22, 2025. Councilperson McCarley seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Mayor Pro-Tem Brown—yes, Mayor Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to approve funds for the 2025 Regional Orientation Training. Councilperson Suggs seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, McCarley -yes, Mayor Pro-Tem Brown – yes, Mayor Bradley-yes. Motion carried.

Mayor Pro-Tem Brown made a motion to approve Resolution 2025-10-13 (A) to Amend the City of Argo Employee Handbook to Allow Donation of Sick or Vacation Time. Councilperson Griffin seconded the motion. Mayor Bradley called for roll call of votes: Griffin -yes, Suggsyes, Hopkins-yes, McCarley -yes, Mayor Pro-Tem Brown – yes, Mayor Bradley-yes. Mayor Pro-Tem Brown made a motion to approve Resolution 2025-10-13 (B) to Establish a Fee for Assessment Letters. Councilperson McCarley seconded the motion. Mayor Pro-Tem Brown made a motion to allow the city to move forward with the Govt Portal pilot program to develop new license and permitting software. Councilperson McCarley seconded the motion.
