The City has received \$100,000.00 from the St. Clair County Commission for the 2026 fiscal year.

The City is currently accepting applications for the Zoning Board and the Zoning Board of Adjustments. Applications must be submitted by November 5, 2025.

PUBLIC COMMENTS – Citizen Michelle Coalson thanked the Council for tabling the ordinance and suggested that the City consider developing a program to assist residents with yard work.

Citizen Beth Dowdy inquired about the Roulain Road Project and stated that residents need assistance with junk removal options.

Citizen Mr. Estes requested signage on Angus Street, stating that Stop Signs and a Hidden Drive sign are needed.

Citizen Corky Massey encouraged residents to attend future Council meetings, stating that citizen input is needed.

Citizen Dee Collier stated that voicing opinions does not seem to have an impact at these meetings.

Brandon Bowman updated the Mayor and Council on Grants Crossing Phase 1. He stated that he will meet with the incoming Mayor Hettich to discuss Norfolk making the crossing a public crossing.

Citizen Paul Jennings thanked everyone for attending the meeting.
