Councilperson Massey made a motion to suspend the rules to waive the first reading and adopt **Ordinance No. 2025-11-03 An Ordinance Adopting and Establishing the Rules of Operation & Procedure for All Meetings**. Councilperson King seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– yes, Hettich-yes. Motion carried.

Reading of **Ordinance No. 2025-11-03, An Ordinance Adopting and Establishing the Rules of Operation & Procedure for All Meetings**, was presented.

Councilperson Suggs made a motion to adopt **Resolution No. 2025-11-03 (A), Designating Councilperson Gordon “Corky” Massey as Mayor Pro Tem of the City Council of the City of Argo, Alabama**. Councilperson Griffin seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– abstain, Hettich-yes. Motion carried.

Mayor Pro-Tem Massey made a motion to adopt **Resolution No. 2025-11-03 (B), Continuing the Appointment of Roy Alan Bulser Jr. as the Chief of Police of the City of Argo, Alabama**. Councilperson King seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– yes, Hettich-yes. Motion carried.

Mayor Pro-Tem Massey made a motion to adopt **Resolution No. 2025-11-03 (C), Continuing the Appointment of Scott Payne as the Fire Chief of the City of Argo, Alabama.**

Councilperson Suggs made a motion to adopt **Resolution No. 2025-11-03 (D), Continuing the Appointment of Amanda McCurdy as the City Clerk and City Treasurer of the City of Argo, Alabama.** Councilperson Griffin seconded the motion. Mayor Pro-Tem Massey made a motion to adopt **Resolution No. 2025-11-03 (G), Retaining Massey, Stotser & Nichols, PC to serve as the City Attorney and City Prosecutor for the City of Argo, Alabama.** Councilperson Griffin seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– yes, Hettich-yes. Motion carried.

Councilperson Suggs made a motion to adopt **Resolution No. 2025-11-03 (H), Retaining Hill, Hill, Gossett, P.C. as Public Defender for the Municipal Court of the City of Argo, Alabama.** Councilperson Griffin seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– yes, Hettich-yes. Motion carried.

Councilperson Griffin made a motion to adopt **Resolution No. 2025-11-03 (I), Continuing the Appointment of Nic Morrison as the City Maintenance Supervisor of the City of Argo, Alabama.** Mayor Pro-Tem Massey seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– yes, Hettich-yes. Motion carried.

Mayor Pro-Tem Massey made a motion to adopt **Resolution No. 2025-11-03 (J), Continuing the Appointment of Steve Tuttle as Chief Building Official and Zoning Administrator of the City of Argo, Alabama.** Councilperson Griffin seconded the motion. Mayor Hettich called for a roll call of votes: Griffin -yes, Suggs- yes, Hopkins-yes, King-yes, Massey– yes, Hettich-yes. Motion carried.

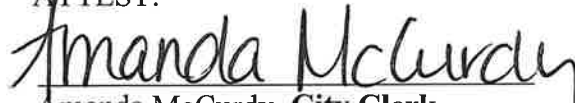
